

Gates Cambridge 25th Anniversary Impact Prize

Entry Form Guidelines

When uploading your nomination, please combine your entry form, CV and supporting documentation; the CV should be added on the next whole page after the entry form, and the supporting documentation should be added on the next whole page after the CV.

- 1a. Write your full name in the space provided
- 1b. Write your email address in the space provided. Please ensure that this is an email address that is checked regularly.
- 2a. If nominating an individual, write their full name in the space provided. If nominating a team, please use the checkboxes to indicate which member of the team is a Gates Cambridge Scholar, and write their full name in the space provided.. If two or more members of the team are Gates Cambridge Scholars, select all appropriate checkboxes and write their full name in the space provided.

If nominating a team, please note that it is the nominator's responsibility to get the consent of the scholar/named team members for the nomination. The maximum size of the team is 4 individuals; at least one of which must be a Gates Cambridge Scholar.
- 2b. Using the space provided, outline the role of the Scholar(s) in the team you are nominating. There is a strict word limit of 50 words for this section.
3. Use the checkbox provide to confirm that you understand and have combined all sections of the entry into a single PDF document.
- 3a. Write the full name of the nominee in the space provided
- 3b. Write the award year as per the Gates Cambridge records in the space provided. The nominee should be able to assist with this information, however, please contact Jack.Earl@admin.cam.ac.uk for support if required. If the Scholar has been the recipient of two Gates Cambridge scholarships, please input the date of the first scholarship.
- 3c. Write the college membership as per the University of Cambridge records in the space provided. The nominee should be able to assist with this information, however, please contact Jack.Earl@admin.cam.ac.uk for support if required. If the Scholar has been the recipient of two Gates Cambridge scholarships with membership of different colleges, please select the first college the Scholar was a member of.
- 3d. Using the space provided, include a biography of the nominee. There is a strict limit of 200 words for this section.
4. Using the space provided, outline the reasons for nominating the individual or team. There is a strict limit of 200 words for this section.
5. Using the space provided, provide evidence of innovation that supports the nomination for this Impact Prize. This could include evidence of: scientific breakthroughs; commercial advances;

new creative approaches to problem-solving; challenging and changing perceptions; deepening cultural understanding. There is a strict limit of 1000 words for this section.

6. Using the space provided, provide evidence of transformation that supports the nomination for this Impact Prize. This could include evidence of: scientific breakthroughs; commercial advances; new creative approaches to problem-solving; challenging and changing perceptions; deepening cultural understanding. This could include evidence of: practical implementation of new methodologies; shifts in national/international policy implementation; influencing how people think about issues. There is a strict limit of 1000 words for this section.
7. Using the space provided, provide evidence of sustainability that supports the nomination for this Impact Prize. This could include evidence of: change that has grown and spread over time and/or from one sector to another; credible evidence of potential for long-lasting change. There is a strict limit of 1000 words for this section.
8. Using the space provided, describe any individual and/or contextual factors relating to the nominee's contribution of which you would like the judging panel to be aware of. This could include: funding constraints; exclusion, marginalization, discrimination, regional conflict, displacement, family commitments. **There is no obligation to complete this section and it will be treated confidentially.** There is a strict limit of 1000 words for this section.
9. Use the space(s) provide to list the main beneficiaries of this individual/team's work. You should not exceed 8 beneficiaries
10. If you are not self-nominating, please include two letters of support from individuals you consider to be well placed to give an informed view of the significance of the nominee's contribution.

If you are self-nominating, please include three letters of support from individuals you consider to be well placed to give an informed view of the significance of the nominee's contribution.

Supporters should be able to provide an independent view and should not be a family member of, or current close collaborator with, the nominated scholar or any team member. Gates Cambridge scholars are eligible to act as supporters.

The word limit for letters of support is 1,500 words. Letters of support should comment on how the writer came to know the nominee(s)' work, the impact of the work that they have observed, and the potential for further impact they see in the work
