FROM THE PROVOST

Professor Eilis Ferran FBA

This report mostly covers the period between the start of the Easter Term 2025 and the end of the Lent Term 2026. It also includes a forward look to the end of the 2025–6 academic year.

Overview of 25th anniversary

The period marked a defining period for the Trust, shaped by our 25th anniversary celebrations. This milestone year was characterised by a strong sense of community, intellectual vitality and reflection on the Scholarship's global impact. Over this period, Bill Gates Sr. House has firmly established itself as a vibrant centre of scholarly and community life.

Building on the Impact Prize Awards in January 2025, we continued to recognise and celebrate the achievements of scholars from across the Trust's 25-year history. A series of anniversary videos celebrating the year received external recognition, winning Silver Awards at both the Digital Impact Awards (Best Use of Digital from the Education Sector) and the Summit Awards Education category).

A dedicated day of celebrations for the 25th anniversary in May 2025 saw the launch of a film about the Impact Prize winners; a roundtable discussion on the future of international scholarships featured Professor Jonathan Holloway (Gates Cambridge trustee), Professor Eilis Ferran, (Provost), Professor Riikka Hofmann (Professor of Education and Gates Cambridge alumna) and Brendan O'Malley, Editor-in-Chief of University World News; and a Research Highlights

session, where six scholars across a wide range of subjects provided insights into their studies and why these matter.

The 2025 anniversary programme culminated in a special celebration marking the 100th birthday of Bill Gates Sr. at which former provosts shared personal memories of Bill Gates Sr. There was also an event celebrating the publication of a commemorative 25th anniversary

magazine and a video series, 25@25, highlighting Scholar impact across the world.

The anniversary magazine features an interview with Dr Mimi Gardner Gates, highlights from the anniversary events, reflections from Scholars across cohorts and in-depth conversations between members of the inaugural 2001 cohort and the 2025 cohort and features on past cohorts and collaborations, underscoring the continuity and evolution of the Gates Cambridge community.

The Trust was delighted to receive portraits of Bill Gates Sr and Dr Mimi Gardner Gates by Joe Park, generously gifted by Mimi. These portraits now hold pride of place in the Scholars Common Room in Bill Gates Sr. House.

New Cohorts

Interest in the Gates Cambridge Scholarship has continued to grow.

For the 2025 entry, the total number of applications to Gates Cambridge reached 8,947, an increase from 7,600

for the 2024 entry, The Trust awarded 90 new scholarships. The Trust actively supports the University's outreach and promotional efforts to ensure that potential Scholars are drawn from the widest possible pool.

Selection rounds took place in Seattle (January 2025) and Cambridge and Singapore (March 2025). The addition of the Singapore interview round has strengthened links between Gates Cambridge and Singapore, in particular with the University of Cambridge Centre for Advanced Research and Education (CARES).

The cherished tradition of new Scholar Orientation has continued. The 2025 cohort has captured their Orientation experience in a film, which underscores the centrality of community to the Gates Cambridge Scholar experience.

The Trust is finalising the 2026 entry as this report goes to press. We expect to welcome a cohort of 73 new Scholars in September 2026.

Scholar Engagement and Activity

The Trust continued its close and productive partnership with the Scholars' Council, delivering a wide range of initiatives and events. The first full revision of the Scholar Council Constitution since its original adoption was a significant milestone.

The Trust and the Scholar Council together developed a new set of community values: the CLICC values (C – compassion; L – learning; I – internationality; C – community; C – change for good). These are intended to be living values that are embedded in everything that we do.

Leadership development was a key theme throughout the period. The *On Leadership* lecture series, launched in the Michaelmas Term 2025, featured a distinguished roster of speakers: Joe Cerrell, MD Europe, Middle East & East Asia, Gates Foundation who kickstarted the series with an insightful talk on adaptive, creative, courageous leadership; alumna Gates Scholar Robyn Scott, co-founder and CEO of Apolitical, a global learning programme for government; and best-selling author Alan Guarino in conversation with University of Cambridge Pro Vice Chancellor Professor Kamal Munir. The annual series will conclude with our Trustee Jonathan Holloway speaking at the Gates reunion weekend in July 2026.

The focus on leadership also extended to the most recent set of podcasts in the Gates Cambridge podcast series, *So, now what?*, Gates Cambridge participation at the Cambridge Festival and the launch of the Trust's new flagship Leading with Purpose programme. It is a pleasure to report that Stephen Metcalf, himself a Gates Scholar, has become our first Academic Director. In this role, Stephen will sustain and deepen the Trust's commitment to the professional development of Scholars as leaders.

Gates Connect

Gates Connect is a dedicated online networking platform for both Scholars in residence and Alumni Scholars. Gates Connect supports professional networking, mentoring opportunities and community-building across cohorts and disciplines, helping to strengthen lifelong connections and promote the ongoing impact of the Trust's global network. Tililenji Phiri has joined the Trust team to support the rollout of the platform.

Looking Ahead to Another Milestone

The Gates Cambridge Weekend (formerly Alumni Weekend) in July 2026 will feature a special reunion dinner marking the arrival of the first cohort of scholars in 2001. The programme for the Weekend will provide wonderful opportunities for networking, reconnecting with old friends and making new ones, and simply enjoying being together in Cambridge.

Beyond celebratory events, we are working hard behind the scenes on operational improvements, including an IT transformation project and a website refresh, aiming to ensure the Trust's systems are fit for purpose as it enters its next 25 years.

The Trust moves beyond its 25th anniversary with a renewed sense of purpose, strengthened community foundations and an unwavering commitment to scholarship, leadership and motivation to improve the lives of others.

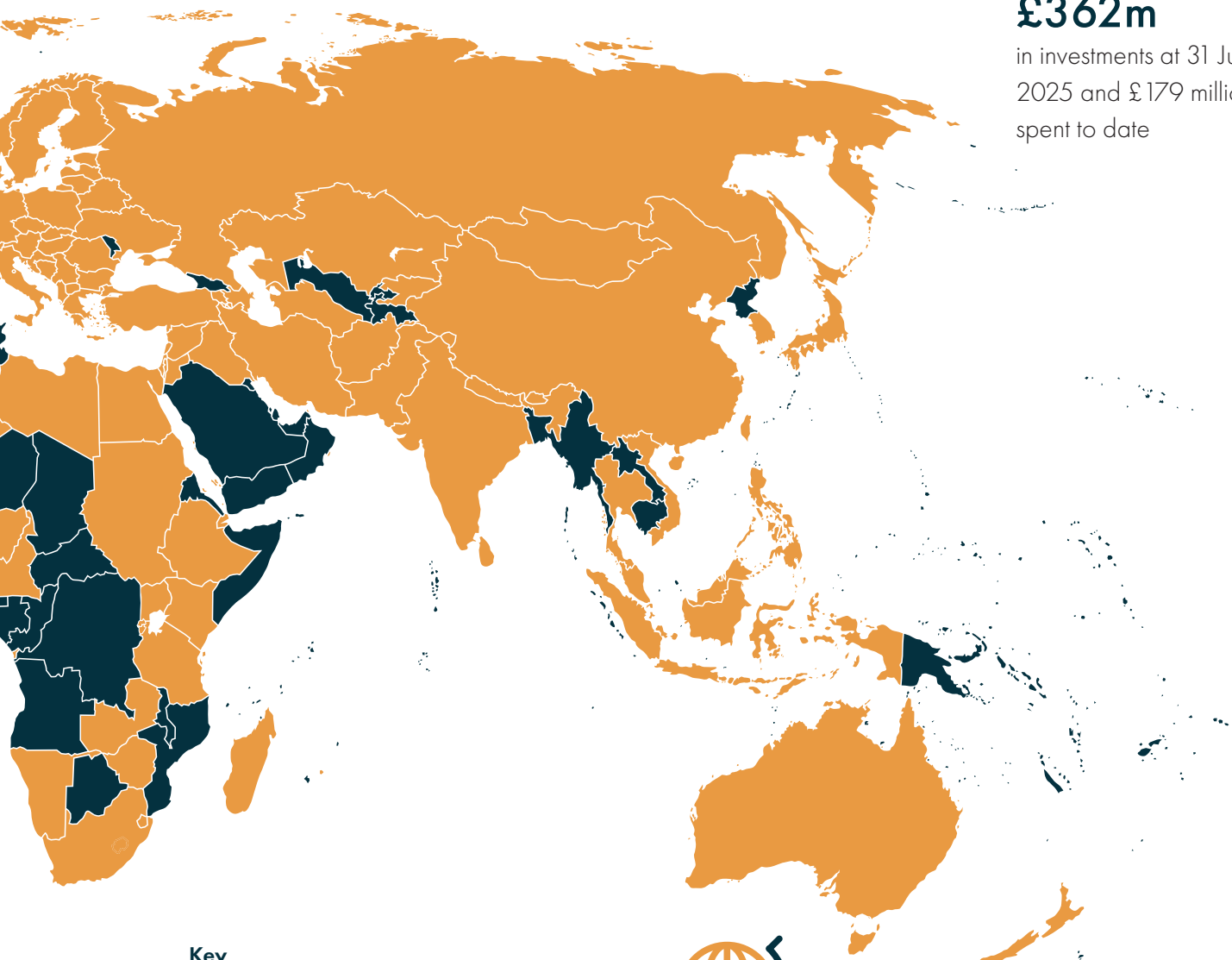

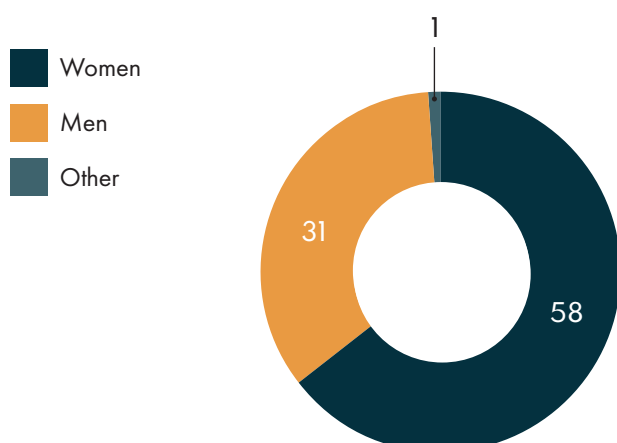

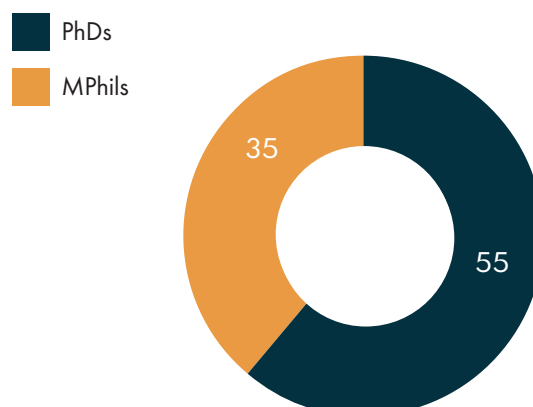
Summary of class of 2025

Scholarships awarded by gender



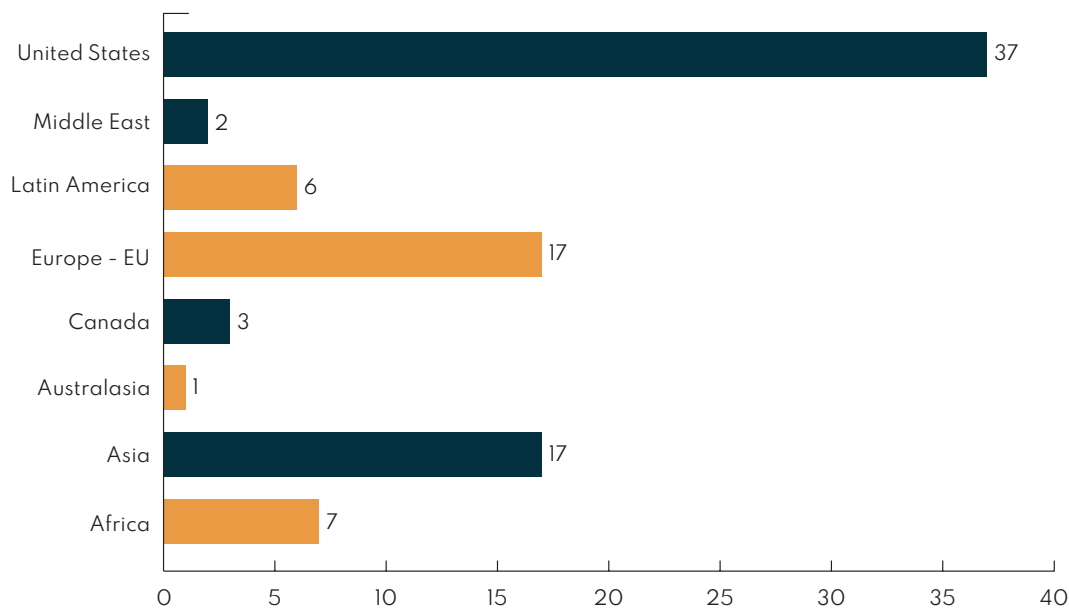
Scholarships awarded by degree type



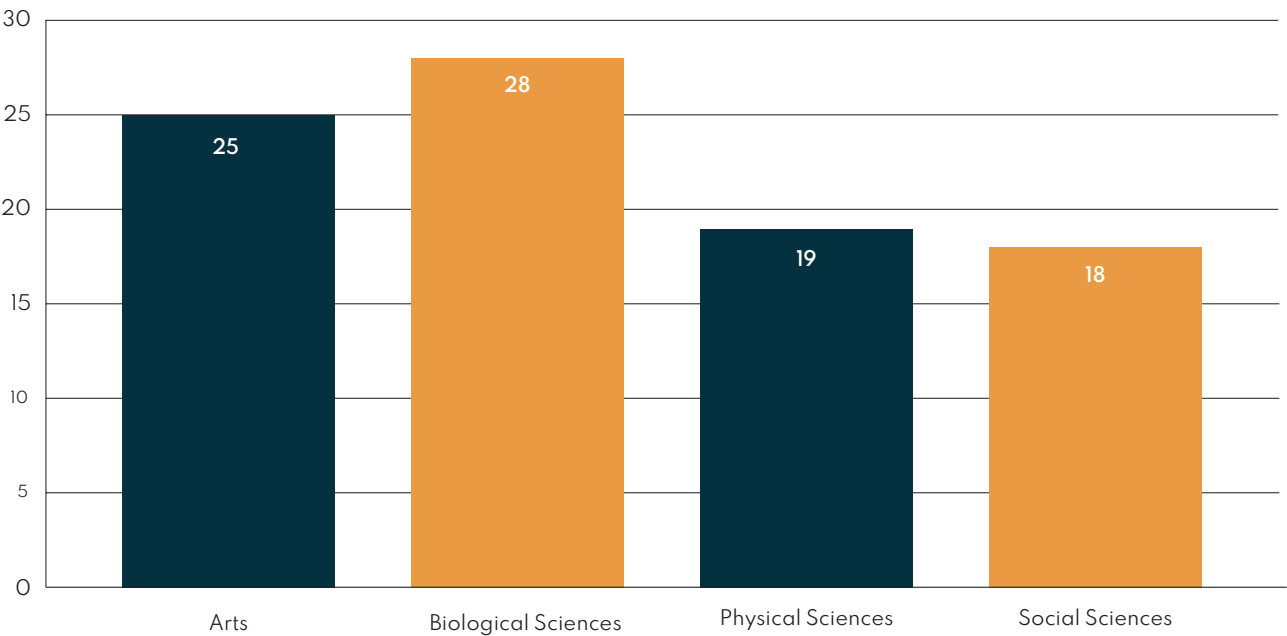

Financial Summary 2024/25

Jade Tran, Director of Finance and Operations

The Trust was established in 2000 with an endowment of US\$210 million from the Gates Foundation. Since its inception, the Trust has awarded 2,218 scholarships to scholars from more than 112 countries. As of 31 July 2025, the Trust's net assets stood at approximately £362 million.

The Trust's largest expenses are scholar maintenance and fees. In 2025, scholar maintenance liabilities increased by £0.81 million.

Support and governance costs have risen compared with the previous year and now account for approximately 8.0% of total expenditure (up from 6.6% in 2024). This increase is largely due to the ongoing maintenance of Bill Gates Sr. House and the one-off Courtyard project. The Trust continues to operate under a hybrid working model, with the office open daily throughout the year.

In addition to core scholarship costs, the Trust funds various initiatives that support the scholar community, including

the Scholars' Centre and financial support for activities organised by the Scholars' Council. Activities were delivered both in person and in a hybrid format, and the Trust highly values the Scholars' Council's contribution. The Trust also values the Scholar Alumni Advisory Committee (SAAC), through which alumni scholar representatives continue to advise on fostering an effective scholar alumni network.

The Trust relies entirely on income from, and the long-term growth of, its investments. It continues to use the Cambridge University Endowment Fund (CUEF) as its primary investment vehicle. The CUEF declares a quarterly dividend, providing predictable cash flows for the Trust. In the year ending 31 July 2025, investment income totalled £14.1 million, and the market value of the Trust's investments increased by £13.31 million (+3.9%). The CUEF performed reasonably well against its benchmarks.

To mark its 25th anniversary, the Trust expanded its cohort by admitting additional scholars, increasing the total to 90 for the 2025–26 academic year.
